STANTON CITY COUNCIL MEETING
October 4, 2011 – City Hall meeting room

In accordance with Section 84-1412 sub section eight (8) of the Revised Statutes Cumulative Supplement 2004, one copy of all reproducible written material to be discussed is available to the public at this meeting for examination and copying and a current copy of the Open Meetings Act is posted in the meeting room.

A closed session may only be held for the protection of the public interest or for the prevention of needless injury to the reputation of an individual and if such individual has not requested a public meeting, as allowed in Section 84-1410 of the Revised Statutes Cumulative Supplement 2004. The Council will review the following items and take such action as they deem appropriate.

A. Call to Order

3. Motion to approve consent agenda *(any changes to agenda may be made at this time)

* All items listed with an asterisk (*) are considered to be routine by the City Council and will be enacted by one motion. There will be no separate discussion of these items unless a Council member or a citizen so requests, in which event the item will be removed from consent agenda status and considered in its normal sequence on the agenda.

5. Notice of meeting was published in the Stanton Register on September 28, 2011 and agenda was delivered to the Mayor and Council on September 30, 2011. Agenda kept continually current at the City Hall.

B. Current Business

The Mayor will ask for comments from the public on each agenda item and may move the order of agenda items. **Each person addressing the city council shall stand, state his / her name for the records, and shall limit his / her address to five minutes.** All remarks shall be addressed to the council as a body and not to any member thereof. No question shall be asked a councilman except through the presiding officer. Comments / questions shall not be made from the audience.

3. Consideration on Library updates (Report concerning current operations of the Library. Questions may be asked and answered. No action can be taken by the Council on matters presented under this title, except to answer any question posed and to refer the matter for further action.)

4. Consideration on approving Resolution 520 for setting designated depositories

5. Consideration on recommendation by planning commission to request DEQ to add an area north of wells to Wellhead Protection Program map

6. Consideration on property located at 503 Locust

7. Approve golfing fee for Tom Wolf Benefit of \$500

8. Approve appointment of Kent Stallbaum to Stanton Fire Department

9. Consideration on options for future staffing in utility departments

10. Public comment period for communications and citizen concern (No action can be taken by the council on matters presented under this title except to answer any question posted and / or to refer the matter for further action.
